- 6. Update on BOC actions:
 - 1. Ngoc Van Nguyen, 2901 Hwy 326, Carnesville, GA 30521 has filed for a conditional use permit for two poultry houses in an Agriculture Intensive (AI) zoning district on a +/- 65 acre tract. The property is located on 2901 Hwy 326 and is further identified as tax parcel 022 024D. **Application Withdrawn**
 - 2. UDC Zoning Map adopted by the BOC on September 19th, 2022 with the condition that citizens can request zoning changes from AG (Agriculture General) to AI (Agriculture Intensive) starting Monday, September 26th, 2022 through Wednesday, November 30th, 2022.
 - 3. BOC decided on October 3rd, 2022 to further clarify that the citizen zoning requests to the zoning map can not include properties that are outside of the AG (Agriculture General) zoning class.
 - 4. Citizen UDC Committee discussed.

New Business

1. Christopher and Katherine Mogenson, 5904 Highway 326, Commerce, GA 30530 have filed an application requesting a Variance to the Franklin County Unified Development Code to "remain Ag District to allow use for a drive thru Safari Park" on a +/- 156.25 acre tract. The property is located at 6210 Highway 326 and is further identified as parcel number 014 017.
