The Timber Harvesting Activity checklist is a reference document only. Please refer to the Franklin County Timber Harvest Ordinance as well as the Georgia Department of Revenue for specific language and instructions related to the forms noted in the checklist.

□ Written Notification of Timber Harvesting Activity

- Complete Notice of Timber Activity Form and submit to the Franklin County Board of
 Commissioners (BOC) office prior to entering onto the property if possible, but <u>no later than 24</u>
 <u>hours after</u> entering onto the property
- Written notification required for each separate tract to be harvested
- May be submitted in person, fax, email, or by mail

□ Bond or Letter of Credit

- Valid surety bond or valid irrevocable letter of credit in the amount of \$5,000
- Notice shall not be in effect unless and until bond or letter of credit has been delivered to BOC
- Only one bond or letter of credit required from each person or firm

Notification of Cessation

- Give notice of cessation of cutting within 24 hours after the job is complete
- BOC will inspect county maintained roads for damage

□ Complete Form PT-283T Report of Timber Sale or Harvest
