<u>James Loggins</u> – lives on a road that has no name. Wants to get the road named in order to get a correct 911 address.

Item 5. New Business

A. Trey Roberts - Southern Linc

LTE network a mission critical network. Tested with county EMS departments and had approximately 98% coverage. Pricing not available on Harris Radios side but can give pricing for Southern Linc. How would your system work with 911 dispatch consoles? Pair with desktop radios to consoles. LTE no towers needed. Internet based app. They have push to talk, call alerts, and ring them over the phone. Southern Linc mobile router could back up internet loss. Monthly radio subscription, can cancel anytime. Southern Linc owned by the Southern Co. Their network is not a consumer network. They deploy temporary towers in emergency situations (example: when towers go down). P25 system radios would work with that system L3 Harris with LTE and Southern Linc. How many paths for channels? They can create as many talk groups as needed. They can create patches to work with other counties. The Georgia State Patrol are beginning to implement their service throughout the state at this time. Stevie Thomas, Sheriff expressed a concern about volunteer fire fighters not hearing a phone. They are volunteers and wear pagers and need to receive a loud enough alert to hear. Southern Linc doesn't offer pager service, but recommend looking into a separate pager system if the county isn't having to pay to build out a radio system.

B. <u>Tax Assessors - EagleView</u>

Additional funding needed. A total of 82 counties in the state of Georgia currently use this program, including Stephens and Banks counties. Airplane aerial photography is used which is clearer and gives more views for county staff to be able to view properties. Images updated every 3 years. February 2024, will be the next aerial photography update. Cost is \$27K over 3 years, by using this program it will save time, resources, staff, and gas.

C. Election qualifying in 2024 – fees need to be set

Historically the fee has been based upon 3% of the starting base salary. Review and place on meeting agenda for January 2024, for a vote.

D. <u>Terry Harris – Intergovernmental Agreement with Franklin County</u> <u>BOE</u>

Sewer expansion to the new school, the Board of Education has signed. Place on meeting agenda for December 4, 2023, for a vote. Agreement has been reviewed and vetted by the Bubba Samuels, BOC attorney and John Phillips, County Engineer.

E. ACCG Mental Health Resolution

Review and place on meeting agenda for December 4, 2023, for a vote.

F. 911 System Upgrade

The 911 consoles need to be replaced. Plans are to research and pick compatible consoles with new radio system in mind. Hope to have a path decided upon the first of the year for a radio system.
