A. Garland and Wendy Parchment, 2910 Buford Drive, Buford, Ga, has filed an application for an Amendment to the Franklin County Zoning Map from Agriculture Intensive (AI) to Light Industrial (LI) on a +/- 6.41 acre tract. The property is located Hwy on 51 and is further identified as tax parcel 012-022. Assistant County Manager DeLozier reviewed the application for the board. The applicants are requesting to rezone their parcel adjacent to the Flying J to build a maintenance shop/office space, and a place to park their trucks. The planning commission recommended approval with the condition of directional lighting to mitigate light pollution.
