Waiver of liability and hold harmless agreement in favor of Franklin County, Georgia

In consideration of being allowed to participate in _____
("Activities") on property belonging to Franklin County, and for other good and valuable consideration exchanged, I, the undersigned hereby agree to the following:

Assumption of Risk - I realize that while conducting the Activities, there are several ways that I could potentially hurt myself if I am not careful or choose a task that I am not capable of doing. Moreover, I agree and acknowledge that these Activities are potentially dangerous and that there are certain inherent risks associated with participation in same, and that I may subject myself to severe physical injury or even death by engaging in these Activities. I acknowledge that my participation in the Activities is strictly voluntary and that I assume the risks associated with these Activities. I could: (a) receive cuts and abrasions, (b) lose personal property such as watches or jewelry, and (c) suffer serious bodily injury or death. There are also risks involved in the Activities that are necessarily associated with intense outdoor activity, such as heat exhaustion and animal bites. I freely assume these and other related risks. While the above are examples of potential risks I may face, they are not meant to be wholly comprehensive.

Waiver - I release Franklin County, the Franklin County Board of Commissioners and all the directors, officers, members, employees, agents, or officials ("Releasees") thereof from all actions or claims of any kind that relate to my participation in the Activities. I understand and acknowledge that this waiver binds my heirs, administrators, executors, personal representatives, and assigns.

Hold Harmless - I hold the "Releasees" harmless and indemnify them against all actions or claims (including reasonable attorneys' fees, judgments and costs) with respect to any injuries, death, or other damages or losses, resulting from my participation in the Activities.

Pictures - I agree that any pictures or videos taken of me or my children/dependents during the Activities may be used by the Releasees for future promotional campaigns. These pictures or videos may be used for such promotional campaigns without permission and with no promise of benefit or gain to the volunteer.
