Chairman Bridges called the meeting to order at 5:30 p.m. He stated there are three items for discussion on the agenda. The items will be discussed individually with an opportunity to speak for and against each one.

**Conditional Use for Telecommunications Tower – Verizon Wireless**

Chris Doyle with Verizon Wireless came forward and stated that Verizon Wireless is proposing a 255-foot self-supporting tower near the corner of Hwy 106 and Broad River Church Road on a 51-acre parcel of land. The proposed cell site connects to other cell sites to the north, south, east and west and will provide improved wireless service to Franklin County. There was no opposition to the request from Verizon.

**Conditional Use for Additional Poultry Houses – Minh Anh Dinh**

Mr. Dinh said there are six poultry houses on his farm. His request is to be allowed to build two additional houses. Commissioner Franklin questioned the location. Mr. Dinh said South Fairview Road. Chairman Bridges questioned if they would be built beside the current houses. Mr. Dinh confirmed yes. There was no opposition to the request from Mr. Dinh.

**Conditional Use and Variance for Additional Poultry Houses – Nguyet-Hang Dinh**

Nguyet-Hang Dinh came forward and requested to build two additional chicken houses. She said her property is located next to her brother and he is okay with her building. Chairman Bridges said the request is for a conditional use and variance. Ms. Dinh said yes and her brother is okay with that. There was no opposition to the request from Ms. Dinh.
